# **Member Spotlight**

Jackie Davis, MLIS, AHIP. Consumer Health Librarian

Jackie Davis, MLIS, is grateful for the work that she does as a consumer health librarian for Sharp HealthCare. Jackie recently received her AHIP designation from the Medical Library Association. The application process was an opportunity to gather the documentation from over the years of professional learning and service, and see her career through the light of these accomplishments.

Jackie has written a number of journal articles and chapters for MLA published books. This year she will have an additional article published in the Journal of Consumer Health on the Internet. In 2015 Jackie participated in the local Evidence Based Project Institute and worked on a team that implemented a health literacy assessment protocol with patients in a progressive care unit. The research has emphasized the best ways for providing written information to patients in an accessible way. While written information will always be valuable for patient education, the results from this project, and from an additional and separate survey of Sharp HealthCare patients, illustrate the value of oral communication for both obtaining patient literacy levels regarding their healthcare and for relaying health information.

In 2016 Jackie gave the MLA webinar, "The Consumer Health Library: A Site for Service, Education and Hope." She communicated the responsibilities of the position as well as the joy it is to come to work each day.

Talking With Your Doctor: Using Information Resources to Improve Health Communication

In August 2016 Albany Medical College's (AMC) Schaffer Library of Health Sciences (SLHS) and Division of Community Outreach and Medical Education (DivCOME) partnered to deliver programs with the intention of improving patient-provider communication. Combining health literacy principles found in information science and public health, we designed workshops with objectives aimed at helping patients prepare for medical appointments and research health information online.

Two community partners, the Center for Law and Justice and Community Caregivers, were identified through the DivCOME's existing relationships. They helped identify content, teaching sites, and advertising avenues. Funding was secured through the National Network of Libraries of Medicine Middle Atlantic Region. AMC's Institutional Review Board approved this project.

Eight interactive workshops with a total of 54 participants were delivered at community sites in urban, rural, and suburban settings. Workshops were evaluated using paper pre-/post-questionnaires, which were entered and analyzed in Qualtrics. A graduate student in public health assisted with workshop preparation and evaluation.

The results were positive. We collected 38 pre-questionnaires (70% response rate) and 36 post-questionnaires (67% response rate). The percentage of participants indicating that they are "Very Confident" or "Confident" in their ability to find good, high quality health information on the internet went from 25% to 91%. 97% indicated that they intended to tell a family member/friend about the websites from this workshop. 100% indicated that after this workshop they will be more comfortable explaining things to their physician, and 97% felt that the workshop improved their ability to ask questions at their next appointment. 97% also indicated that they would change where they looked for health information based on the workshop.

Building on the success of Year 1, Year 2 funding supports collaboration with five public libraries to deliver the community workshops and to provide professional development opportunities to their librarians. We developed a MLA 4 credit CE course "Patient Empowerment: Using Information Resources to Improve Health Communication" based on the theory behind the community workshops. While designed for public librarians, the course is relevant to anyone working with patients. Local sessions began in September 2017. Two additional consumer health classes will be taught at each library, so that by the end of the year, 20 librarians can apply for Level 1 CHIS designation.

#### **Book Reviews**

Mimms, Kayrene. **Fighting Lupus Battles: Hope For A Cure. True Stories From Lupus Warriors.** Chicago: Hilton Publishing Co., 2015. 201p. ISBN: 9780990428329, \$17.95.

When faced with the challenges of living with and battling a disease, many find comfort, encouragement, and inspiration from hearing the experiences of "fellow travelers," as they offer testimony that the disease, no matter how difficult, can be dealt with and lived with. Kayrene "Kay" Mimms and all the "Lupus Warriors" included in the text strive to live "their best life with Lupus."

In 2004 Mimms, the youngest of eighteen siblings, retired from a career in teaching. One year later, and after suffering with various symptoms for years, she was near death from a lupus flare. Mimms sought out as much information as she could find on lupus. In this work, Mimms shares information, and the experiences of several "Lupus Warriors," written in their own words. Sections are devoted to stories about Lupus Warriors diagnosed during Pre-Teen and Teen Years, those diagnosed during Young Adult Years, and those diagnosed later in life. Reading the experiences of "Lupus Warriors" as they share their disease history, treatment, and support of their family and loved ones is both enlightening and encouraging.

As one contributor, Kanefus R. Walker states, "We are fighting a disease that is killing us from the inside out, and most don't seem to understand that except the people who are affected by it" (Mimms 111). Librarians should take special note of the chapter "A Physician's Perspective," where Rosalind Ramsey-Goldman, MD, DrPH, reviews each of the lupus warriors' chapters, and offers a "Teaching Point" for each one. As she observes "Learn as much as you can about the disease. Knowledge can be empowering" (Mimms 161).

Mimms concludes with an appendix, definitions, and a list of "References/Resources," that lists contact information for organizations that can be of assistance to those who deal with this difficult disease.

This work is highly recommended.
