Librarians as Researchers: Practicing What We Preach in Scholarly Publications

Contributed and invited papers

Do librarians follow their own advice about scholarly publication practices? Do they publish their findings in indexed journals or proceedings, provide access to their publications, and perform citation analysis of their own works? Topics for contributed papers in this session may include the behavior of librarians as authors in their own literature and as coauthors in systematic reviews, and clinical or research studies. Practices for consideration include, but are not limited to, presence of librarian-authored or coauthored works in institutional repositories, evidence of negotiation of author agreements, review of licenses and contracts for key library journal and book publishers, librarian publishing in open access journals, posting of preprints from librarian authors on their own sites or the staff publications

section of their library websites, critical appraisal and summary of the literature that perpetuates the discussion of library research, and tracking of the impact of publications through citation alerts and assessment of citations or links to published work.

The advent of both digital content and new forms of communication has made radical changes in the expectations of health science library users for access to information.

Responding to the opportunities provided by these changes, some librarians and libraries have changed their focus, no longer emphasizing libraries as keepers of the information universe but instead stressing their ability to

provide expertise in support of those who work in the health information universe. A number of new paradigms have been reported at conferences and in the media: embedded librarians, e-science experts, support for translational medicine, and data curation and management. To help us gain a better understanding of these new paradigms, the Journal of the Medical Library Association is planning to devote our October 2013 issue to papers that focus on the outcomes experienced by those who have taken on these new roles.

This is just one example that dispels the myth that everything is free on the Internet. Everyone trying to develop evidence based health programs needs access to a health science library (or a very responsive public, academic or school library) that subscribes (licenses) journals most



responsive to their organization's needs, and arranges for copies of resources they do not own or license. Organizations with library services include some, but not all, insurance/managed care providers. If your organization does not have a library, you can try searching WorldCat <http://www.worldcat.org/> to find a library near you that owns the journal (in this case, Health Services Research). This resources covers most larger libraries, but not all smaller ones such as those serving hospitals and health systems. For those organizations, the library home page (Intranet or WWW) will have a feature that lets you know what journals they have.

You can also write to authors once you have a full citation with their email - usually found in PubMed record. And, some U.S. states have online full-text access to databases that include full-text of journal articles.

In the long run, what you really need is organizational and/or public health support for library services, including access to a qualified librarian with appropriate education , including ongoing CE. If you do not have this via your employer, you may have some services via membership(s) in professional organizations. Please use this information need as an opportunity to approach your management about these needs. If you do have access, please ask your librarian(s) how you can support their role within your organization. Libraries and library positions are going away because management does not see the benefit.
