If you have more staff, additional site licenses (valid for 25 staff each) may be purchased. The cost for an MLA institutional member is \$500 on or before May 26, 2017 and \$700 after May 26. For non-MLA-institutional members the cost is \$800 on or before May 26 and \$1,000 after May 26 Individual single-user e-conference registrations are also available for MLA members for \$159 per person at www.mlanet.org.

You may access online content beginning May 1, 2017. Exclusive access continues for one year after the meeting. Content includes:
