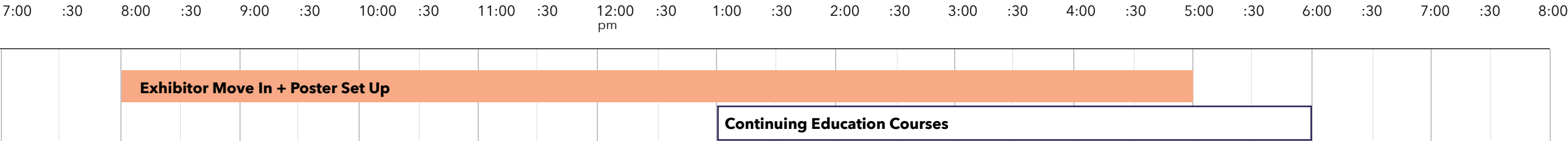

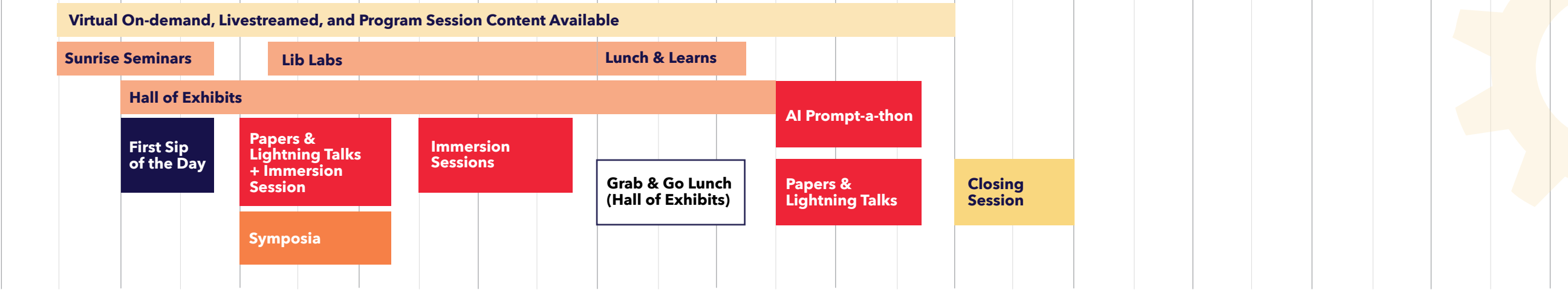

# Featured Speakers



## John P. McGovern Lecture Gabriel T. Bosslet, MD

Gabriel Bosslet is Professor of Clinical Medicine in the Department of Pulmonary, Critical Care, Sleep and Occupational Medicine and is Assistant Dean for Faculty Affairs and Professional Development at Indiana University School of Medicine. He is the former Fellowship Director for Pulmonary and Critical Care Medicine. He sees patients in the ICU at University and Eskenazi Hospitals and in his neuromuscular pulmonary diseases clinic in Indianapolis, Indiana.

Gabe received his bachelor's degree from the University of Notre Dame and his MD from The Ohio State University. He completed his residency in internal medicine and pediatrics at The Ohio State University/Columbus Children's Hospital in Columbus, Ohio. Gabe completed his fellowship in Pulmonary and Critical Care Medicine at Indiana University, where he completed a Clinical Ethics Fellowship at the Charles Warren Fairbanks Center for Medical Ethics and a Master of Arts in Philosophy and Bioethics. Gabe is the past president of the Good Trouble Coalition, a grassroots coalition of Hoosier healthcare and public health stakeholders who collaborate to educate, empower, and facilitate political advocacy to improve life in Indiana in the areas of patient-centered care, public health, and health equity. He is also one of the cohosts of Hoosier Health Matters, a podcast about public health policy in Indiana.



## Janet Doe Lecture Shannon D. Jones, EdD, M.Ed, MLS, AHIP, FMLA

Shannon D. Jones is the director of Libraries and serves as chair of the Academic Affairs Faculty for the Medical University of South Carolina. She is also the director for Region 2 of the Network of the National Library of Medicine. Before she arrived at MUSC, she worked as the Associate Director for Research and Education for Virginia Commonwealth University's Health Sciences Library in Richmond.

A long-time volunteer of the Medical Library Association, Jones has served the Association in many capacities, including the 2022-2023 MLA President. During her term as MLA President, she established the Be Well MLA initiative to encourage MLA members to prioritize their wellness and well-being. In 2018, she co-founded the MLA Reads Virtual Book Discussion Club to provide a forum where participants engage in critical conversations related to their work as information professionals and in their personal lives. She is the coeditor of Diversity and Inclusion in Libraries: A Call to Action and Strategies for Success and Cultural Humility in Libraries. She focuses her research on staff recruitment and retention, belonging in libraries, wellness and wellbeing for information professionals, and leadership in academic health sciences libraries.

## AI Prompt-a-thon: Applying Prompt Engineering to Real-World Library Challenges

This session offers attendees a competitive, hands-on experience with AI prompting, grounded in a real-world challenge faced by medical librarians. Facilitators will introduce prompting frameworks and present a scenario in which librarian teams will complete assigned tasks using AI tools. Participants will analyze provided data, craft communications, and generate outreach materials using AI. Prompts and outputs will be submitted via a shared form, and a rubric will be used to determine a winning team. A dedicated prompt refinement station will be available to support teams needing guidance. The session will conclude with a facilitated discussion on techniques, strategies, and ethical considerations in AI use.

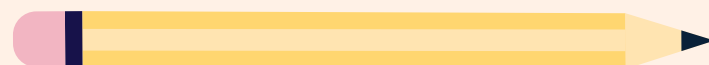

If you will be part of a systematic review team—or if you already do systematic review searches and want to hone your skills—this is the searching course for you! The course will take you through the systematic review searching process, from confirming the need for a review and identifying appropriate databases to creating search strategies and

documenting and reporting searches using PRISMA-S. PubMed is the primary database used in the course. The heart of the course is developing an extensive, effective, systematic, translatable, and replicable search strategy to address a research question. You'll receive feedback on searches during the session.

You'll also learn how to conduct a reference interview to properly define a topic and how to translate a topic into effective search concepts. And you'll be able to participate in the search peer review process that is now elemental to the searching community of practice.

Rather than trying to chase every new AI tool or headline, librarians need durable, transferable skills for evaluating AI, integrating it responsibly, and supporting users who bring AI into their work. This course focuses on practical approaches to AI literacy—helping health sciences librarians understand what these tools can do, where they fall short, and how they can be meaningfully applied across teaching, research support, scholarly communication, and internal library workflows.

Laura Hall, MFA, MBA, Division Head for Resources, Archives & Discovery at the University of New Mexico’s Health Sciences Library & Informatics Center, leads UNM’s AI Crossroads program, offering faculty, staff, and students practical guidance and timely conversations on AI. From 2023–2025, she co-led UNM’s work on Ithaka S+R’s national Making AI Generative for Higher Education research project and has presented widely on generative AI in higher education and health sciences settings. Drawing on real-world library

experience, Laura will lead participants through demonstrations, case studies, hands-on activities, and a collaborative mini “promptathon” designed to build fluency and practical skills. You’ll leave with clear, adaptable strategies for evaluating AI tools, applying effective prompting techniques, and guiding students, faculty, and clinicians in responsible use. This session is designed to help medical and health sciences librarians bring grounded, practical AI literacy into their professional practice.

This hands-on workshop aims to help librarians gain practical skills to outline a concept paper and proposal brief. Grants have long been a tool that allows libraries to increase their reach and offer access to more communities. Libraries are seen as a trusted bridge connecting communities with information and resources. They are often at the intersection of various disciplines, projects, and funding opportunities, making librarians a natural fit to lead grant development. The shifting realities of public, academic, and health sciences libraries today necessitate

that information professionals must, more frequently, seek external funding for such projects. Yet few librarians are formally trained in grant-writing, nor in marshaling together a team of grant-seekers with varying positions, experiences, and knowledge fields. In addition, the institutional support staff that might have traditionally helped with such endeavors has frequently disappeared from rosters due to budgetary constraints within their institution, meaning that librarians seeking grants often do so without the support often provided to academic researchers.

Using resources from *The Librarian’s Grants Handbook: Understanding the Grant Process from Start to Finish*, this session will highlight major areas in proposal writing, including identifying goals and objectives, budgeting, designing your evaluation plan, and tools and approaches to help you develop a proposal. Participants will leave with an understanding of the grant writing process, tools and resources, and an understanding of the next steps.

## AI for the Uninterested: How We Learned to Stop Worrying and Use AI

### Topics: Artificial Intelligence

Artificial intelligence is transforming how information is created, accessed, and evaluated in biomedical settings. Librarians as a trusted resource are positioned well to guide this shift. This session, led by self-avowed non-AI experts, demonstrates how professionals without technical expertise can engage meaningfully with AI in health sciences libraries. Blending diverse perspectives, audience engagement, and planning, this session is designed to be highly interactive and to support those who grudgingly see AI increasingly integrated into our professional practice.

## Cheddar Together: The Power of Evidence Synthesis Apprenticing

### Topics: Systematic Reviews

With the demand for expert librarian support for systematic reviews/evidence synthesis projects outpacing the capacity of trained librarians and limitations of formal training opportunities, librarians have been struggling to onboard new hires. This session will present sustainable options for onboarding cohorts of new librarians in evidence synthesis through mentorship and co-learning. Participants will learn about onboarding mechanisms and feedback processes so that similar programs may be implemented at their institutions. Over the course of the session, panelists that are proficient or new to evidence synthesis will share experiences as they gained skills and confidence and will facilitate discussions for participants to think about and share their ideas for how to effectively onboard librarians into this work in sustainable ways.

When the new NIH Public Access Policy went into effect, NIH-funded manuscripts that were accepted for publication on or after July 1, 2025, were required to become freely available in PubMed Central immediately at the time of journal publication. This transition from a 12-month embargo period to a zero-embargo has caused confusion for authors who now had to navigate new journal policies, additional copyright considerations, and updates to self-archiving their accepted manuscripts. This session will feature panelists who will share their insights and experience to help inform others on how they can best support their users in navigating the 2024 NIH Public Access Policy.

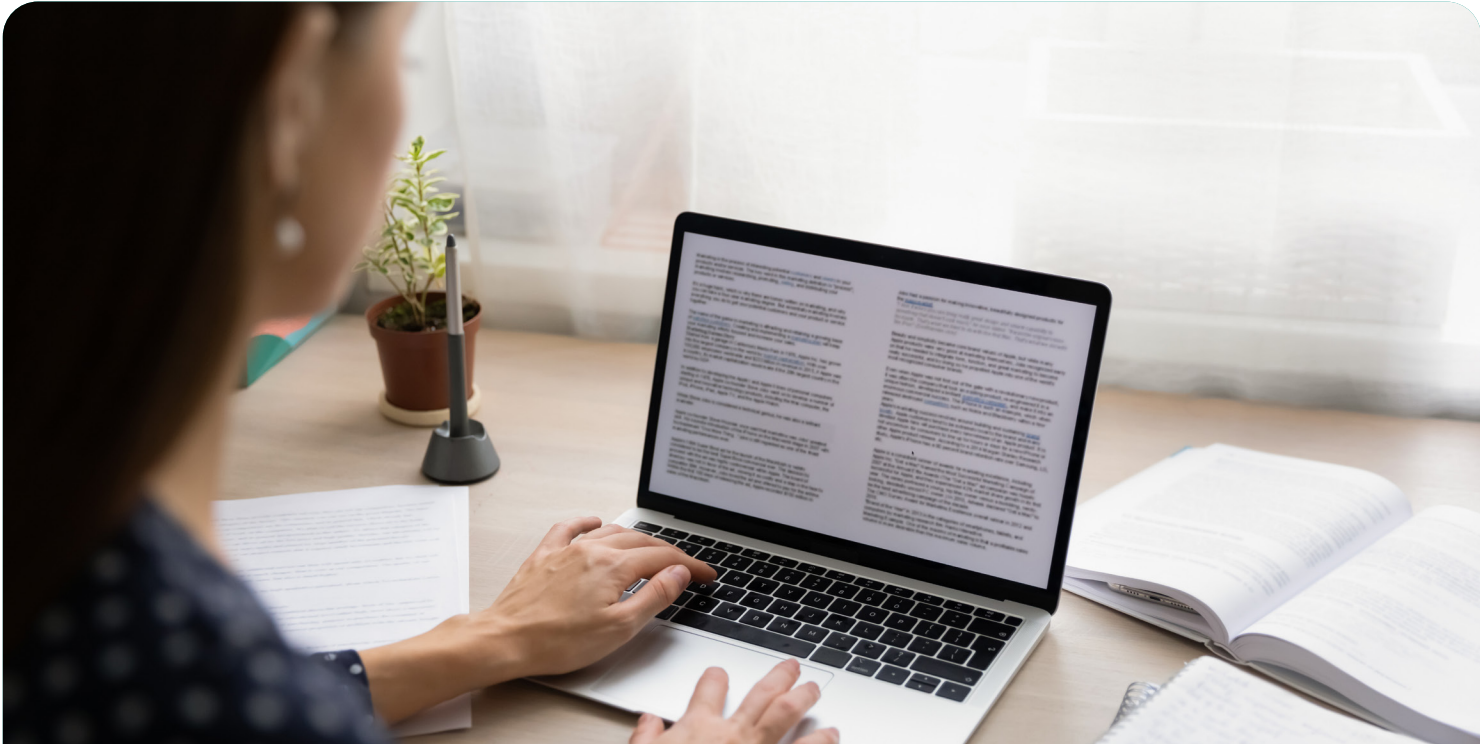
